2. Birtamode Municipality, Office of Municipal Executive, Birtamode Jhapa invites electronic bids from eligible bidders for the construction of following works under National Competitive Bidding.

6. Pre-bid meeting shall be held at Birtamode Municipality, Office of Municipal Executive, Birtamode Jhapa at 2076/01/15 (28th April, 2019) at 15:00 hours.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2076/01/27 (10th May 2019) at 13:00 hours at the office of Birtamode Municipality, Office of Municipal Executive, Birtamode, Jhapa. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format, amounting to a minimum of mention below in table which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
10. All other issues shall be considered as per Public Procurement Act 2063 including latest amendment & Public Procurement Regulation 2064.
