1. Birtamode Municipality has allocated funds towards the cost of construction of Black Topped Road with Side Drains and intends to apply part of the funds to cover eligible payments under the following works. Bidding is open to all eligible bidders as per Section V of Bidding Document.
2. Birtamode Municipality, Office of Municipal Executive, Birtamode Jhapa invites electronic bids from eligible bidders for the construction of Bhagwanchowk-Birtabajar Black Topped Road with Side Drains (Ch: 0+000 to 0+700) at Birtamode-3 under National Competitive Bidding-Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs. 3,85,00,000/-
 - Minimum Work Experience of similar size and nature: NRs. 2,05,00,000/-

6. Pre-bid meeting shall be held at Birtamode Municipality, Office of Municipal Executive, Birtamode Jhapa at 2075/12/15 (29th March, 2019) at 13:00 hours.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2075/12/27 (10th April 2019) at 13:00 hours at the office of Birtamode Municipality, Office of Municipal Executive, Birtamode, Jhapa. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format, amounting to a minimum of mention below in table which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
10. All other issues shall be considered as per Public Procurement Act 2063 including latest amendment & Public Procurement Regulation 2064.
