- 8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hrs on 2077/11/26 at Birtamode Municipality, Office of Municipal Executive, Birtamode, Jhapa. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format, amounting as mention in table below which shall be valid for 30 days beyond the validity period of the bid.
