Birtamode Municipality, Office of Municipal Executive, Birtamode Jhapa invites electronic bids from eligible bidders for the Construction of Atithisadan – Jagatbasti Road at Birtamode-1 and Meghabari –Kanchanjunga School Road at Birtamode- 4 under National Competitive Bidding-Single Stage Two Envelope Bidding procedures and Construction of Yatayat – Birtabajar Road at Birtamode-3 under National Competitive Bidding-Single Stage One Envelope Bidding procedures.

5. Pre-bid meeting shall be held at Birtamode Municipality, Office of Municipal Executive, Birtamode, Jhapa at 13:00 hrs on 2076/11/15
6. Electronic bids must be submitted to the office Birtamode Municipality, Office of Municipal Executive through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00 hrs on 2076/11/25.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hrs on 2076/11/25 at Birtamode Municipality, Office of Municipal Executive, Birtamode, Jhapa. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting as mention in table below which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
